



2017-2018 Verification Worksheet - Dependent Student

Your 2017-2018 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information the financial aid administrator at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

B. Family Information

- Your parents' other children, even if they don't live with your parent(s), if (a) your parents will provide more than half of their support through June 30, 2018, or (b) the children would be required to provide parental information when applying for Federal Student Aid for 2017-2018. Include children who meet either of these standards, even if they don't live with your parent(s).
- Other people if they now live with your parents, and your parents provide more than half of their support and will continue to provide more than half of their support through June 30, 2018.

C. Tax Forms and Income Information

1. **TAX RETURN FILERS- Important Note:** If the student or the parent (s) filed or will file an amended 2015 IRS tax return, the student must contact the financial aid administrator before completing this section.

If the student or the parent **did not use** the IRS Data Retrieval Tool in the FAFSA on the Web, then the student and parent(s) must correct their FAFSA using the IRS DRT or submit to the school a **2015 IRS Tax Return Transcript- NOT** a photocopy of the income tax return. *To obtain an IRS Tax Return Transcript, go to www.irs.gov and click on the "Get Transcript of your Tax Records" link, or call 1-800-908-9946. You can get your transcript on-line or by mail. Make sure to request the "IRS Tax Return Transcript" and NOT the "IRS Tax Account Transcript." You will need your Social Security Number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2015 IRS tax return was filed). It takes up to two weeks for the IRS income information to be available for electronic IRS tax return filers, and up to eight weeks for paper filers.*

2. **TAX RETURN NONFILERS---** Complete this section if the student or parent(s) will not file and is not required to file a 2015 income tax return with the IRS. *(We may require you to provide documentation from the IRS that a tax return was not filed.)*

Check which applies:

- The student was not employed and had no income earned from work in 2015.
- The parent(s) was not employed and had no income earned from work in 2015.
- The student and /or parent(s) were employed in 2015 and have listed below the names of all the student's and parent (s) employers, the amount earned from each employer in 2015, and whether an IRS w-2 form is attached. Attach copies of all 2015 IRS W-2 forms issued to the student and parent(s). *List every employer even if they did not issue an IRS W-2. If more space is needed, attach a separate page with the student's or parent(s) name and Social Security Number at the top.*
