Dr. Simon invited Hallie Ferguson to the meeting to present her with several blankets and bags for her organization, Bags of Love. Ms. Ferguson was a foster child herself until she was adopted at the age of 12. She started her organization to help other children entering the foster care system. Bags of Love provides an outfit, blanket, pair of shoes, toy or stuffed animal and a small Bible in a duffle bag or backpack. Ms. Ferguson is an Angelina College Student majoring in Child and Family Development and will graduate in May 2019. Dr. Simon stated that Angelina College is very proud of her and what she is doing for our community.

Presentations were made from Human Services, Heavy Equipment Simulation Lab, Child Development, Drafting, Fluid Power, Electrical, Machine Tool and HVACR. Bids and Proposals

Advertisements were publically issued and vendors were provided bid requests for a PLC Drive Trainer Package. One bid was received. Janice Huffman, Director of Grants and Sponsored Programs, reviewed the bid. The purchase will utilize Skills Development Fund grant funds. It was recommended that the Board approve the purchase of one PLC Drive Trainer Package in the amount of \$33,520.32. Motion made by Dr. Roberts to approve the purchase and seconded by Mr. Deason. Motion carried unanimously.

Consideration of Health Careers II Roof Replacement

Dr. Simon presented a recommendation for the Board to approve a purchase to replace the Health Careers II roof by Merritt Roof Systems, Inc. in the amount of \$70,091.00. The College would make the purchase using the State of Texas's TIPS Interlocal Purchasing Systems. After some discussion, Dr. Roberts made a motion to approve the purchase. Motion was seconded by Ms. Temple and approved unanimously.

Consideration of Administration Building Renovation

Dr. Simon asked Mr. Poland to not consider this item. The college would like to include value engineering and will revisit at next month's meeting.

Racial Profiling Report & Audit from Texas Commission on Law Enforcement
