CARES Act

Angelina College will soon be able to provide emergency financial grants to students to help cover expenses related to disruptions due to the coronavirus such as food, housing, course materials, technology, health care and child care through the Coronavirus Aid, Relief and Economic Security (CARES Act).

CARES Act Funding Institution Disclosure

The Department of Education requires that each institution participating in the Higher Education Emergency Relief Fund (HEERF) must post the information listed below on the institution's primary website.

The following information must appear in a format and location that is easily accessible to the public 30 days after the date when the institution received its allocation under 18004(a)(1) and updated every 45 days thereafter.

Update Reporting Cycle

Grantees posting a 45-day report on or after August 31, 2020 should instead post a report every calendar quarter, with the next calendar quarter report due by October 10, 2020 and covering the period from after their last 45-day or 30-day report through the end of the calendar quarter on September 30, 2020. Additional report periods ending December 31, March 31, and June 30.

Angelina College Response:

Angelina College was allocated \$1,306,478 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students (CARES).

On January 19, 2021, Angelina College was allocated a supplemental award of \$1,306,478 from the Department as part of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA).

On May 12, 2021, Angelina College was allocated a supplemental award of \$4,389,643 from the Department as part of the American Rescue Plan Act of 2021 (ARP).

Angelina College Response:

Angelina College disbursed CARES Act funds to all Title IV Eligible students registered in the Fall 2020 and Spring 2021 semesters. The amount of funds that were distributed was determined by dividing the number of eligible students by the amount of funds received.

Each team member reviewed and discussed the eligible student list, criteria for distribution of funds to students, the requirements of the grant, and determined the amount of funds to distribute to each student.
