The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

Angelina College Response:

In April 2020, Angelina College was allocated \$1,306,478 from the Department pursuant to the institution's Coronavirus Aid, Relief, and Economic Security Act (CARES).

In December 2020, Angelina College was allocated a supplemental award of \$1,306,478 from the Department as part of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA).

In May 2021, Angelina College was allocated a second supplemental award of \$4,741,711 from the Department as part of the American Rescue Plan (ARP).

Angelina College Response:

As of May 31, 2021, Angelina College has distributed \$1,306,478 funds in Emergency Financial Aid Grants to students from CARES and \$1,306,478 from CRRSAA.

Angelina College Response:

Angelina College disbursed \$1,100 in ARP funds to all Pell Eligible students registered in the Fall 2021 semester. Other students, not eligible for Pell and excluding dual credit students, received \$600 during the same semester.

The eligible student list was reviewed by the CARES team. Each team member reviewed and discussed the eligible student list, criteria for distribution of funds to students, the requirements of the grant, and determined the amount of funds to distribute to each student. The team included individuals from:
