# MINUTES REGULAR MEETING ANGELINA COLLEGE BOARD OF TRUSTEES August 21, 2023

The Angelina College Board of Trustees met in the Administration Board Room of Angelina College. Officers present were Dr. Robert Lindsey, President; Mr. Curt Fenley, Vice-President, and Mr. Malcolm Deason, Secretary. Members present were Ms. Hilary Haglund-Walker, Mr. Gilbert (Joey) Garza, Dr. Sid Roberts and Ms. Lynne Haney.

College personnel attending the meeting were Dr. Michael Simon, President; Mr. Chris Sullivan, Vice President of Business Affairs and In-House Counsel; Dr. Tim Ditoro, Vice President of Academic Affairs; Ms. Dee Ellis, Advancement Officer; Dr. Catherine Aguilar-Morgan, Dean of Science and Mathematics; Ms. Krista Brown, Associate Vice President of Student Services; Ms. Janice Huffman, Director of Grants & Sponsored Programs; and Leigh Ann Pyle, Manager of President's Office and recording secretary.

Dr. Lindsey called the meeting to order at 5:38 p.m.

#### COMMENTS TO THE BOARD

There were no comments to the board.

# APPROVAL OF MINUTES OF PREVIOUS MEETING

Dr. Lindsey asked if there were any additions or corrections to the minutes from the previous meeting of the Board on July 17, 2023. There being no corrections under terms and no other additions, Dr. Sid Roberts made a motion to approve the minutes of the July 17, 2023 regular board meeting. Ms. Hilary Haglund-Walker seconded the motion and the motion carried unanimously.

#### **ACTION ITEMS**

Consideration of FAST Dual Credit Program

Dr. Lindsey asked Dr. Simon to present the details of the program.

Initial Summary of Topics Discussed

- Tuition & Fees set at \$55 per semester credit hour for dual credit students
- Economically Disadvantaged/Free and reduced lunch Dual Credit Students will pay \$0 (state to reimburse \$55/credit hour)
- Non-Economically Disadvantaged Students ISD to pay tuition & Fees
- How does the College know which students are free or reduced lunch?
  - ISD reports to TGA, THECB to cross reference & provide eligibility

When discussing the above it was noted that about 1/3 of our enrollment is from dual credit.

Hilary Haglund-Walker made a motion to approve the FAST Dual Credit program. Mr. Deason seconded the motion and the motion passed unanimously.

Consideration to adopt a Resolution Authorizing the Issuance of the Note for Payment of Lawful Expenditures of the District

Dr. Simon and Mr. Sullivan went over the financial documents for the resolution authorizing the issuance of \$377,750 for Angelina College Maintenance tax note, series 2023; and Authorizing other matters relating to the issuance of the note for payment of lawful expenditures of the district.

A motion was made by Dr. Roberts to approve the resolution. Mr. Garza seconded the motion and the motion passed unanimously.

Consideration of Preliminary 2023-2024 Budget

Dr. Simon and Mr. Chris Sullivan presented the proposed 2023-2024 budget. Dr. Simon stated that the Finance Committee met earlier this month to review the budget. The committee's recommendation to approve the Budget was presented and came as a seconded motion from the committee. Motion passed unanimously.

Consideration of Proposed Tax Rate and Scheduling of Tax Rate Hearing Date
The proposed tax rate will be \$0.152428 which is effectively a 5.44 percent increase in the tax rate

The Public Tax Hearing is scheduled for September 11, 2023 at 12:30 p.m. in the Administration Boardroom of Angelina College. Motion was made by Mr. Fenley to approve the hearing date and time and seconded by Ms. Hilary Haglund-Walker and approved.

Consideration of First Bank of Livingston Resolution

Dr. Simon asked the board to consider signing a resolution to adjust the authorized signatures and close the account at First Bank of Livingston.

Dr. Roberts made a motion to approve the change in authorized signatures and to close the account at First Bank of Livingston. The motion was seconded by Mr. Fenley and passed unanimously.

Consideration of an Amendment to the FY24 Personnel Plan

Dr. Simon recommended an amendment of adding one administrative assistant for Institutional Advancement and Student Affairs.

After this discussion, Dr. Roberts made a motion to approve the personnel amendment. Ms. Haney seconded the motion and the motion passed unanimously.

Consideration of Transportation Services

Advertisements were placed in the Lufkin Daily New and personalized invitations to bid

were sent to several firms for Transportation Services for Angelina College. Two proposals were received.

Based on analysis of the proposals, it is recommended the 2023 Transportation contract be awarded to Echo AFC Transportation in the amount of \$195,392. This amount does not include travel for regional tournaments and any applicable national tournament travel. Additional expenses will be incurred for these events.

Mr. Garza made a motion to approve the bid from Echo AFC Transportation. Ms. Hilary Haglund-Walker seconded the motion. The motion passed unanimously.

Consideration of Revisions, Deletions or Additions of Board Policy

Dr. Simon presented the policies up for consideration. Dr. Simon stated that the Policy Committee met earlier this month to review the policies. The committee's recommendation to approve the policies presented and came as a seconded motion from the committee. Motion passed unanimously.
