#### **The Report**

The Annual Security and Fire Safety Report provides information on policy and procedures concerning the safety and security here at Angelina College.

The report also identifies and explains the College's Standard Response Protocol (SRP) for emergency management incidents.

AC employees, students, and community members are encouraged to use this report as a guide for safe practices on and off campus.

To remain in compliance with provisions of federal law, the College is required to report specific types of crimes that occur on campus property, including the residence hall, any reported crimes on public property, and any fires on AC property.

This report details incidents for January 1, 2024 through December 31, 2024. The report also notates statistics for 2023 and 2022.

#### Reporting to the Angelina College Police Department (ACPD)

ACPD strongly encourages the campus community to promptly report crimes or emergencies to ACPD, even if/when the victim of a crime cannot or will not make a report. It is important that all criminal activity be reported immediately and as accurately as possible. Crimes may pose a high level of risk or be dangerous to the broader AC community, so they must be reported immediately to minimize any potential harm to other individuals or property.

ACPD investigates and reviews all reports and complaints of criminal activity that occur on campus and off- campus if the crime involves an employee or student within ACPD's jurisdictional boundaries.

Crimes reported to the ACPD are included into this annual statistical disclosure. When necessary, the Standard Response Protocol (SRP) and/or Emergency Notifications are initiated in consultation between the ACPD and the College's executive leadership team.

### **Reporting Title IX Incidents**

## **Confidentiality and Anonymous Reporting**

All College employees except those deemed confidential employees have a mandatory reporting obligation for sexual harassment, sexual assault, dating violence, and stalking under <u>Texas Education Code Section 51.252</u> and cannot honor requests for confidentiality.

In the event confidentiality cannot be maintained, the College will share information only as necessary and only with people who need to know to fulfill the purposes of policy and applicable laws.

Those identified as campus law enforcement authorities as defined by the Clery Act have an obligation under federal law to report all Clery Act offenses to the title XI coordinator.

The only employees exempt from reporting under the Clery Act are professional and pastoral counselors while operating under the scope of their license. These employees are encouraged to provide confidential reporting resources to the person they are counseling when a criminal offense is disclosed. Professional and pastoral counselors may also disclose the offense to the Campus Police without identifying the patient by using any electronic means.

Individuals wishing to remain anonymous may file a report over the phone or in writing. The decision to remain anonymous may greatly limit the College's ability to stop the alleged conduct, collect evidence, and take action against the parties accused of violations or crimes. Anonymous reports are counted and disclosed in the crime statistics for the College, but, as with all other crimes included in this report, no personally identifiable information is included.

### **Police Department Role & Authority**

#### Working Relationship with Local, State & Federal Law Enforcement Agencies

The Angelina College Police Department has a Memorandum of Understanding (MOU) with the Lufkin Police Department for the City of Lufkin to serve as our dispatch and communications center. The ACPD also has a positive, professional working relationship with all Sheriff's, Police Departments and Texas Department of Public Safety in the 12-county region. ACPD also maintains a relationship with the local FBI Office as well.

#### **Crime Prevention Education**

It is the intent of the Angelina College Police Department to inform the campus community of good crime prevention efforts as well as security awareness practices. The Police Department and Law Enforcement Academies, (Police & Fire), provide a wide range of educational opportunities in an effort to promote campus safety and aid in anticipating and minimizing potential dangers to the population and property of Angelina College.

- O Civilian Response to Active Shooter (CRASE) training is available, upon request, to students, faculty, and staff.
- The Police Department also provide awareness training to students during orientation.

# **Crime Prevention and Activities for on Campus Housing**

- O Monitor and respond to calls for service and fire alarms
- O Safety prevention and contact information for Police and Fire in each residence hall room
- O Residence Hall guidelines provided to students

- On-Duty Police and Security Officers make regular rounds by the residence hall each shift.
- O Safety programs offered throughout the year
- O Background checks on each new, in-coming residence hall applicant
- Background checks conducted on all maintenance, contractors and subcontractors working in or at the residence hall
- Orientation conducted with each student who lives in residence hall each semester

#### **Crime Prevention Devices in Place**

- O Calls received directly by Police Security 24/7 via cell phone
- Retention reporting system
- O Stay Alert Stay Safe Email system
- O Campus Crime Stoppers program
- Video Surveillance Systems throughout public areas in buildings and entire campus
- O Door mag locking system on building entrances/exits and each classroom for improved interior safety
- The Standard Response Protocol from the "I Love You Guys" foundation

#### **Crime Prevention Tips**

- ₱ Always keep residence hall doors locked
- ♣ Ensure that all personal belongings are out of sight when securing vehicles
- ♣ Do not leave personal belongings or electronics unattended

- - 1. Inform a friend, relative, roommate, of the route that you are traveling
  - 2. Remain aware of your surroundings
  - 3. Walk in well-lit areas
  - 4. If you feel that you are in danger or are being followed, immediately contact the Police Patrol via cell phone, 936-676-2563.

### **Timely Warnings**

The Angelina College Police Department has a responsibility to provide "Timely Warnings" to the campus community about reported crimes in a manner that will aid in the prevention of similar crimes and to provide emergency notifications when health and safety of the campus community is at risk.

#### **Determination of a Continued Threat**

Timely Warning determinations are made when all circumstances have been met and a crime is considered to be a serious or on-going threat to the College community. Timely Warnings are assessed on a case-by-case basis, but would typically be issued for:

- Murder/Non-Negligent Manslaughter.
- O Major Incidents of Arson.
- O Sexual Assault

Reports of sexual assault are elevated on a case-by-case basis. Issuing a timely warning for sexual assault is contingent on the facts of the specific case, when and where the incident occurred, when it was reported, and the amount of information known by the Chief of Police or designee.

O Robbery

Timely warnings are typically issued for robberies involving force or violence. Cases involving pick-pocketing and purse snatching will typically not result the issuance of a timely warning notice, but are elevated in an individual basis.

O Aggravated Assault

Assaults among known parties, such as two roommates fighting, resulting in an aggravated injury, are evaluated to determine if the individual is believed to be an ongoing threat to the larger Angelina College community.

#### O Burglary

Timely warnings typically involve cases in which an investigation has determined that multiple incidents are likely related.

O Motor Vehicle Theft

Timely warning typically involves cases in which an investigation has determined that multiple incidents are likely related.

#### **Text Messaging Mass Notification System**

The College utilizes third-party software to send text messages to members of the campus community. The communication platform, RAVE, is used for mass notification and response personnel notification. Emergency notifications and instructions are sent via text messages, phone calls, and emails to phone numbers and emails that are registered with the College. It is extremely important that every student and staff member register their phone number and email with the College to ensure they receive emergency notifications. Notifications can be sent to all members of the College community or to smaller, select groups to activate specific portions of the emergency response plan. Students are automatically enrolled to receive emergency College communications via text message, but it is important that they alert the College of any changes to their contact information. Faculty and staff should sign up to receive emergency text messages and emails through the Angelina college Human Resources Department.
